

F.1. 2024 Tax Forfeiture Update

Marc Iverson, Land Records Coordinator, and Alex Buysse, Land Records Specialist, reviewed the decision of the US Supreme Court ruling declaring Minnesota's Tax Forfeiture Law violates the Constitution. This affects properties sold during the period June 2016 through December 2023 above the minimum sales price. The Board was informed of the legislative changes and the settlement process.

G.1. Review Cannabis Ordinances Discussion

Presentation was provided by Chad May and Brenda Theis, Assistant County Attorneys, and Angie Berg, Environmental Services Supervisor. Ms. Berg addressed amendments to the Land Use Zoning Ordinance and answered questions from the Board. Cannabis Licenses are pre-approved by the OCM (Office of Cannabis Management). Environmental Service's role is to approve the location and assuring standards are met. Mr. May and Ms. Theis reviewed the proposed Cannabis Events, Retail Business Registration and Compliance Ordinance and answered questions of the Board. After much discussion, motion was made to set a public hearing date of November 19, 2024, for consideration of said proposed ordinance. This will allow for more time for additional information and notification to Stearns County townships and small cities for possible enactment by their entities versus establishing their own ordinance.

BE IT FURTHER RE-SOLVED, that the County Board hereby adopts the proposed budget totaling \$210,696,207 for 2025.
