RESOLUTION TO ESTABLISH A SUBORDINATE SERVICE DISTRICT FOR THE IMPROVEMENT OF FIRESIDE ROAD, FIRESIDE CIRCLE AND FIRESIDE COURT

WHEREAS, residents of Wakefield Township residing on or near Fireside Road, Fireside Circle and Fireside Court have expressed an interest in having said road improved to current Township road standards and the costs of said improvements assessed back to the benefiting property owners; and

WHEREAS, a Petition requesting the creation of a Subordinate Service District for the bituminous improvement of that portion of Fireside Road, Fireside Circle and Fireside Court located within Wakefield Township, Stearns County, Minnesota, was filed with the Wakefield Township Clerk; and

WHEREAS, the Town Clerk reported to the Wakefield Town Board of Supervisors that the required 50% of signatures had been verified and in conformity to Minnesota Statutes Chapter 365A; and

WHEREAS, a Public Hearing was scheduled for and held on the 9th day of January 2025, at 6:30 p.m.; and

WHEREAS, all statutory legal requirements regarding giving notice have been satisfied; and

WHEREAS, the Wakefield Township Board of Supervisors determined that the creation of a Subordinate Service District to be in the best interest of the landowners of said area.

THEREFORE, BE TI RESOLVED, that the Wakefield Township Board of Supervisors, Stearns County, Minnesota do hereby establish a Subordinate Service District pursuant to Minnesota Statutes Chapter 365A with the following stipulations and conditions:

A. The following Subordinate Service District is created and established for the area graphically depicted on the map attached hereto as Exhibit A and incorporated herein by reference.

B. The purpose of this Subordinate Service District is for the bituminous improvement of Fireside Road, Fireside Circle and Fireside Court for all of the benefited residents.

C. The Subordinate Service District will be financed as follows:

The costs of to improve Fireside Road, Fireside Circle and Fireside Court to current Township Road standards are the sole responsibility of the benefiting residents within the Subordinate Service District. Nothing in this paragraph shall be interpreted as to limit the rights of the Township to use Minnesota Statutes Chapter 429 or other relevant statutes to finance future road improvements to said roads. A property tax levied upon the benefited users in the proposed "Fireside Road, Fireside Circle and Fireside Court Road Improvement" Subordinate Service District or a levy of a service charge against the benefited users, or a combination of a property tax and a service charge on the benefited users shall finance the capitalization, construction, operations and management of such services described above.

D. The Wakefield Township Board of Supervisors shall establish rules and regulations for the proposed improvements to Fireside Road, Fireside Circle and Fireside Court for the Subordinate Service District as necessary.

E. The Subordinate Service District shall become effective upon passage of sixty days (60 days) from the publication of this Resolution.

F. Nothing in this Resolution shall be interpreted that the Town Board has accepted Fireside Road, Fireside Circle and Fireside Court as Township roads. Such road acceptance shall be by a separate resolution adopted by the Town Board.

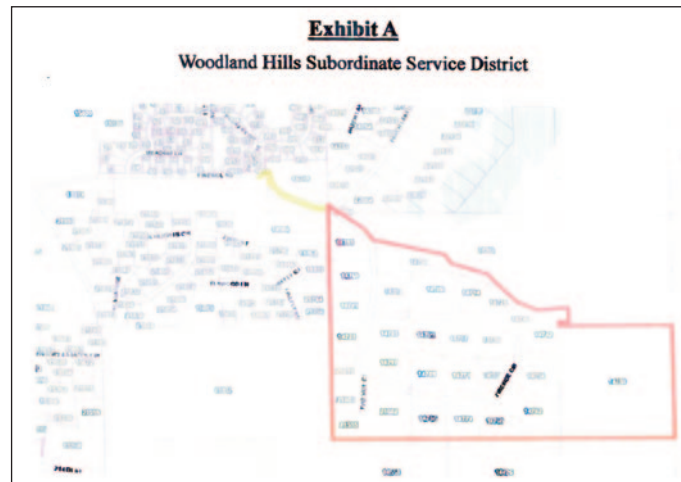
G. The Town Clerk shall cause this Resolution to be published and shall give mailed notice as required by law.
