PUBLIC NOTICE: MDA Publishes BMP list for the Cold Spring Drinking Water Supply Management Area

The Groundwater Protection Rule was developed to minimize nitrate pollution to Minnesota’s groundwater from fertilizer sources and provides a blueprint to work with local farmers and ag stakeholders to reduce nitrate loss to groundwater.

On January 15, 2020, Cold Spring was designated a Level 2 Drinking Water Supply Management Area (DWSMA) under the Groundwater Protection Rule due to elevated levels of nitrate-nitrogen in one of its public wells.

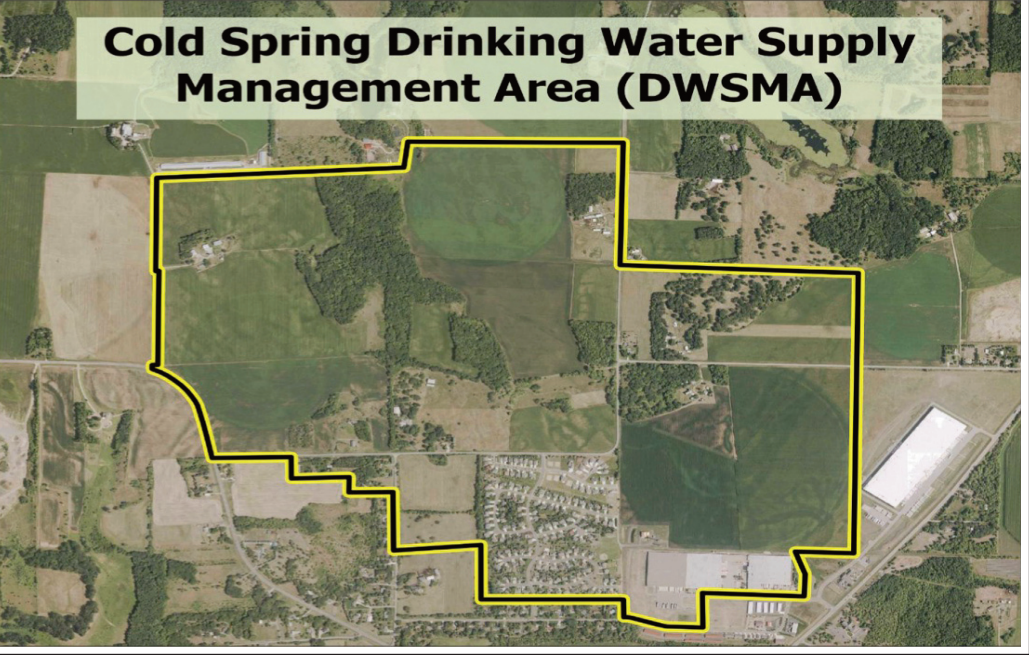
Working with a local advisory team that includes farmers and agronomists operating cropland within the DWSMA and City of Cold Spring staff, the Minnesota Department of Agriculture developed the following list of nitrogen best management practices (BMPs) to protect groundwater in the area. A detailed list of these practices and associated definitions is available at www.mda.state.mn.us/coldspring-dwsma.

- Apply nitrogen to dryland corn at or below the low end of the 0.15 Maximum Return to Nitrogen (MRTN) in the University of Minnesota’s nitrogen fertilizer application guidelines. Currently, this is:
 - o 135 lbs nitrogen/acre for corn following soybeans
 - o 165 lbs nitrogen/acre for corn following corn
- Apply nitrogen to irrigated corn at or below the 0.10 MRTN in the University of Minnesota’s nitrogen fertilizer application guidelines. Currently, this is:
 - o 180 lbs nitrogen/acre for corn following soybeans
 - o 210 lbs nitrogen/acre for corn following corn
- For all other crops grown within the DWSMA, nitrogen rates must follow the current University of Minnesota guidance applicable to that crop.
- Account for all nitrogen sources when calculating nitrogen rate.
- Take appropriate credits for previous legume crops and manure used in the crop rotation.
- Split applications of nitrogen fertilizer on coarse texture soil.
- On coarse-textured soils use nitrogen stabilizer on labeled crops when applying at early sidedress.

In addition to this notice, letters were sent to farmers and landowners to ensure that everyone operating cropland in the DWSMA follows the BMPs. MDA staff will continue to work with local farmers and other partners to raise awareness about the importance of these practices, provide technical assistance, and identify funding to support management changes.

The MDA will conduct an evaluation to determine whether these practices are implemented on at least 80% of all cropland in the DWSMA, excluding soybeans. If BMPs are not adopted on 80% of the cropland acres or if nitrate levels in public wells increases, the DWSMA may move to a Level 3 in which requirements for nitrogen fertilizer management are issued. This evaluation will occur no sooner than three growing seasons after the BMPs are published and could occur as early as fall 2029.
